



# FIXTURE SERVICE – TERMS AND CONDITIONS

The Syncronorm Depence Software requires a so called "fixture-library". These library files contain all necessary information to simulate and control a specific DMX fixture using Depence. Syncronorm provides a public "fixture-library", which gets shipped with the software. This library will be frequently updated with fixtures of all known manufacturers.

# 1. Required technical resources

In order to create the fixtures as realistic as possible, Syncronorm requires as much as technical details about the product as possible like:

- CAD Drawings and/or low poly 3D-Models
  - Low poly models ~2000 polygons
  - o CAD drawings including dimensions
  - Pictures and/or Videos of the Fixture
    - o in case of water & SpecialFX features
    - to match used materials
  - Technical Documentation
    - Unique fixture naming and description
    - Fluid characteristics for fountains (flow/height)
    - Photometrical details for lights
- IES if available
- Beam/Field Angle & Intensity
- Color Temperature
- DMX-Sheets
  - Clear definition for each DMX channel and value ranges
  - Correct naming and functionality explanation

Providing all information in a sorted form, helps to speed up the process.

### 2. Free of charge Service

## 2.1 Definition of Service

Syncronorm offers a free of charge service for all Syncronorm Depence license owners to create and provide manufacturer specific Fixture definition files on demand. This service is limited to Fixtures that must be known and available to the public for purchase. Custom- or customized Fixtures are not provided for free.

Please mind keeping your fixture requests in a reasonable scope and avoid overloaded requests or spam. Otherwise, Syncronorm can unfortunately not guarantee the timely delivery of fixtures.

Fixtures from publicly available product catalogs are usually included in the free service. Exceptions are requests from manufacturers. Syncronorm can only process fixture requests free of charge, which have not been sent in by the manufacturer of the same. Requests from the manufacturer will be charged and treated as a special fixture request. In this way we guarantee a fair and punctual handling of all fixture requests.

2.2 Copyright and ownership

All resulting fixture files are property and under copyright of Syncronorm GmbH. All fixtures, provided by the free-service of Syncronorm, will be publicly available for all Depence users through the asset cloud.

# 3. Exclusive Fixture Service

- high priority fixture service
- custom or customized fixtures

### 3.2. Service fees

Syncronorm herewith assures that all technical resources (drawings, CAD-files, 3D-Models) and information, provided by the manufacturer are only used by the Syncronorm Team, remain confidential and won't be shared with any third party.

### 7. Governing law

This Agreement shall be governed by the law of Germany, applicable therein. You hereby irrevocably attorn and submit to the non-exclusive jurisdiction of the courts of Germany therefrom. If any provision shall be considered unlawful, void or otherwise unenforceable, then that provision shall be deemed severable from this License and not affect the validity and enforceability of any other provisions.
